Dear Chair Stefanski, Chair Hewitt, and Members of the Committees on House and Governmental Affairs and Senate and Governmental Affairs,

On behalf of the Louisiana Chapters of Delta Sigma Theta Sorority, Inc., we hereby request that the Louisiana House and Senate Governmental Affairs Committees provide real time virtual access to the upcoming 2021-2022 legislative roadshow hearings on redistricting for the citizens of this State.

Delta Sigma Theta Sorority, Inc. (DST) is an international organization of a sisterhood comprised of college-educated women founded on the principles of sisterhood, scholarship, and service, with the Sorority engaging in issues impacting the Black community and boldly confronts the challenges of African Americans and, hence, all Americans. Delta Sigma Theta is a preeminent service-based sorority, with more than 300,000 initiated members and over 1,000 chartered chapters worldwide.

In Louisiana, we have over seven thousand (7,000) members from twenty-seven (27) Alumnae Chapters and sixteen (16) collegiate chapters located in cities, towns, and rural communities throughout the State. Social Action is a major focus of the sorority, and under the direction of our National Social Action Commission, redistricting has been identified as one of our top social action priorities for 2021-2022.

In furtherance of this priority, the National Social Action Commission has established redistricting cohorts in all fifty (50) states, including Louisiana. The overarching goal of the redistricting cohorts is to ensure equity and fairness in the redrawing of political district lines resulting from the 2020 census count. In keeping with our national goal, members of the Louisiana Redistricting Cohort are working diligently as concerned citizens of our State to participate actively in the redistricting process and also to inform, educate, and engage our statewide membership on redistricting.

In this regard, the recently published redistricting roadshow hearing schedule indicates that in-person hearings will take place in the major cities and population areas of the State. However, many of the citizens of Louisiana, including our members, live in rural areas that would require them to drive for more than an hour each way to attend the nearest in-person hearing. In addition, many of our fellow Louisianians, including our sorority members, are in the process of recovering from the devastating effects of Hurricane Ida. As such, traveling long distances to a hearing in the next several months will not be possible for them. Lastly, Louisiana continues to struggle through the coronavirus pandemic and many of the cases reported are tied to community spread. Therefore, for these reasons, we request that all of the redistricting roadshow hearings be made available throughout the State on the appropriate virtual platform(s), in real time. This will allow all interested citizens to view and hopefully participate in the hearings, without the necessity of appearing in person. It is critical that Louisiana's redistricting process be transparent and accessible to all citizens of the State. This requested accommodation will go a long way in making that a reality.
